- Curt Wilton moved to ask Doane Perry to take minutes of the meeting.

County Selectmen's meeting October 13

• All three Selectmen said they expect to attend the meeting. Curt Wilton might have a conflict. The meeting is a dinner at Chrissie Farm in Great Barrington. The State's Lieutenant Governor is the featured speaker. Who pays for the \$40 dinner was an open question.

Joint Meeting with Richmond Selectmen, October 4th, at Richmond Town Hall

• The West Stockbridge and Richmond Selectmen will meet together in the Richmond Town Hall on Wednesday evening October 4 at 6 pm. The agenda includes instruction, shared services, ambulance and next steps plus citizen speak.

Noise bylaw special permit application

The Selectmen approved the request by Nathan Bradbury at 26 State Line Road for a special permit for Saturday September 23 for a
wedding. The permit allows amplified music to exceed 30 decibels, per article 14 of the Town's bylaws, ending by 11 pm. The application
says Nathan has checked with his neighbors.

Cable TV discussion

- The agenda for the discussion was 1. Appoint an access coordinator and 2. Approve the responsibilities of the cable commission and access coordinator laid out in the plan document submitted to the Selectmen on July 24, 2017.
- Peter Skorput said he has no problem with the plan.
- Curt Wilton asked if the the plan comes from the commission or from Richard Squailia. Richard replied from the commission. Curt
 commented that Richard did a good job.
- Curt Wilton said that getting channel 2 going is his priority and asked if the commission needs more equipment. Richard replied that the commission is all set with \$10,000 available. He said channel 2 will be up and running within ten days after the commission's plan and the access coordinator are approved by the Selectmen. Curt asked Richard to hold on to the old equipment and to donate it to the Town's safe disposal program.
- Commissioner Bill Barth asked how the commission will access funds. Curt replied that Mark Webber will provide access through
 requisitions to a revolving account.
- Richard said payment for videographers will be "PTSD scale" for videoing, editing and sending to Charter. Curt urged that the community including Monument students be involved. Richard commented that the PTSD training is a gem of the Berkshires funded by the Five [cable] Towns. Richard commented that West Stockbridge becoming a Sixth Town and getting program feeds from all the towns would be a later step for future consideration.

- Curt Wilton commended the Cable Commission for getting things done and for being go-getters in a program that has been dormant.
- Richard Squailia promised to work with the Board of Selectmen and to tell them how it is going and to bring people in the access program in to meet the Selectmen.
- Selectman Bernie Fallon asked how automated the video system will become and could Mark Webber turn it on at the beginning of a Selectmen's meeting? Richard said not yet.
- Richard reminded the Selectmen of their agenda to approve the duties and responsibilities that the Commission has submitted.
- Bernie Fallon asked if the Town Counsel has reviewed the plan?
- Curt made a motion that the Board of Selectmen would approve the plan after the Town Counsel reviews it. Peter seconded the motion, and all three Selectmen voted for it.
- Similarly, the Selectmen voted 3-0 to approve the Cable Access Coordinator's job description after review by Town Counsel.

- Selectman Bernie Fallon presented three articles to the Selectmen and to the Local Yokel on Identity, Community and Communication which Bernie hopes will help West Stockbridge to 1. Get clear on who we are, 2. Get together as a Community and 3. Develop understanding through communications.
- Curt Wilton supported Bernie's proposal and said "Community Workshop Board of Selectmen's Corner" will be on the agenda of every
 future Board of Selectmen's meeting.

Commercial Marijuana Ban

- Richard Squailia presented the Board of Selectmen with a request to amend the general bylaws and the zoning bylaws to ban [prohibit] establishments related to marijuana not medically prescribed.
- Richard said a ban is needed because the time frame for effectiveness of a moratorium has passed.
- Curt Wilton said he would listen but not comment on the matter in the current meeting.
- The Selectmen voted 3-0 in favor of Curt's motion, seconded by Peter Skorput, to take the matter under advisement.
