- Discussed the noise ordinance
 - In limbo at the moment with the select board
 - Truc Orient Express is appealing the building inspector's enforcement of the current ordinance
 - The ZBA is dealing with the lack of action in terms of an appeal
 - There is a select board hearing to determine whether or not to renew the Foundry's special permit
 - It is apparent that the town needs a way to measure sound to enforce the bylaw
 - There is a major focus on decibel levels and not enough on frequency which has been brought up at the meeting – lower frequency sounds can be considered more annoying than higher frequency sounds
 - We have offered our sound measuring meter to the planning board
 - Joe and Frank will make a determination whether or not the meter can record frequencies
- Ron Kujawolski (sp?) is interested in joining our committee
 - Karen will broker an introduction and Joe will introduce him to the group and the meetings
- Discussed the charging station
